



### **Is my participation mandatory?**

- Yes. Costco Mexico is asking all suppliers to have items sold to Costco loaded in their data pool by 20.01.2018 for US Vendors and 28.02.2018 for MX Vendors. This process is a business requirement for all suppliers.

### **Why has Costco chosen to synchronize data through the GDSN?**

- The GDSN process demands enriched data and enhances merchandising and promotional strategies.

### **What information is Costco Mexico asking for?**

- Costco needs the information that is currently in the Costco Item Agreement you complete today.

### **How is the data I provide being used?**

- Costco Mexico uses item data for product listing, ordering, and supply chain. GDSN publications are also used for Costco's new item setup process.

### **Are there costs?**

- Yes. If you choose FSEnet+ as your certified data pool, an FSEnet+ representative can walk you through the implementation options including publication through the GDSN.

### **Why did Costco Mexico choose FSEnet+ as their certified GDSN data pool?**

- FSEnet+ is implementing Costco's data recipient toolset, which allows Costco to fully integrate and validate product information from suppliers, through the GDSN, and to Costco's back-end systems.

### **My company subscribes to another GDSN data pool. Are we able to publish our information through our current data pool?**

- Yes. Any information that can be sent through the GDSN can be published to Costco. Please notify and request a GDSN subscription from FSEnet+ if you will be publishing data through the network.

### **How do you recommend that we proceed?**

### **We see several "Optional" fields turned on. Which fields should we attempt to populate?**

- We are in the process of defining more specific guidelines that apply to different product types. While those are being developed, please attempt to provide the data that is appropriate for your publication.

**What are your attribute requirements?**

- Costco lists our attribute requirements in the Implementation Guides located on our landing page [here](#).

**What attributes will you be integrating to your internal systems. When will it start affecting EDI orders?**

- We will begin integrating attributes in early 2018. We are asking our suppliers to pre-publish the data so that our new item setup and ordering processes are not impacted come early 2018.

**How will GDS effect the new item agreement for Supplier sales team and the Costco buyers/merchandising department?**

- We plan to automate the majority of the new item agreement via GDSN publications. However, pricing/costing and supply chain attributes will still be required on a separate item agreement during some weeks.

**How will the GDSN data be used? Is it exploratory only?**

- The data will be used to update and cleanse our master data. It will also be used to prepare our systems for the integration and automation happening in early 2018. Eventually, it will be used to enrich our online content for e-Commerce.

**What is the Costco process for managing item changes? Will Costco be actively processing item changes sent via GDS?**

- For now, please communicate item changes the way you normally communicate them today in addition to publishing them via GDSN. We will inform you with any process changes prior to early 2018 cutover.

**Can Costco accept test publications prior to publishing the full catalog of Costco items?**

**What CICs will Costco send? If there is a perceived data issue, will Costco use the CICs to include comments?**

- Please refer to our [Implementation Guides](#) for questions on CICs. We will use the CICs to include comments on any questions or discrepancies with data.

**When publishing the item information, should suppliers publish it at the Case level or Pallet?**

- Suppliers should publish item data at all levels if available. This includes Each, Inner, Case, and Pallet.

**Should Suppliers publish Kirkland Signature branded items to Costco US & Canada?**

- Yes. Suppliers should publish Kirkland Signature items.
